Bidders/ auctioneers are invited for auction of E-Waste Electrical and other miscellaneous general items of Estate Branch located at Administration Plaza, Administration Building, JNU, as per lists- "A" for E-Waste and "B" for general items attached, through Spot Auction on "AS IS WHERE IS BASIS" shall be held at 11:30 AM on **18-01-2021** at Administration Plaza, Administration Building, JNU.

Interested bidders/ auctioneers can inspect the material at the above-mentioned location before auction, in between 10:00 AM to 11:25 AM on **18-01-2021** in presence of Shri Rohit Kumar Contact No. 01126704025 on auction day. For details please visit JNU website at www.jnu.ac.in/tender. The terms and conditions on the auction are as under.

- a) The auction is on "AS IS WHERE IS BASIS."
- b) The bidder should have valid registration certificate as per e-waste rules with Ministry of Environment & Forest / Central Pollution control Board / Delhi Pollution Control Committee (DPCC) under Delhi Govt. Document on registration and validity of authorization shall be produced with the bid. Agencies without having above registration and authorization will be not allowed to participate in the bid.(List of registered recyclers attached herewith).
- c) The bidder shall have to provide services required at New Delhi/ Delhi.
- d) The firm may enclose sufficient documents regarding execution of Government Work order, specifically Disposal of e-waste.
- e) Every participating bidder has to deposit earnest money in the form of demand draft/pay order for Rs.10,000/- (Rupees ten thousand only) in favor of "Finance Officer, JNU" before start of auction. Earnest Money of unsuccessful bidder shall be refunded immediately after completion of auction process. No demand draft/ pay orders shall be accepted after start of auction / bidding process.
- f) No bidder shall be allowed to participate in the bidding process without depositing the earnest money. Cheque/Cash shall not be accepted as EMD amount.

g) The highest bidder shall have to deposit 25% of the bid amount immediately on-the-post in cash or in the form of DD/Pay order/NEFT/RTGS in favor of Finance Officer, JNU, after adjusting the earnest money deposited by the bidder and the balance 75% of bid amount within the 07 days of issue of order for acceptance of bid the 25% bid amount deposited by the bidder shall be forfeited and bidder shall not be allowed in re-bidding process further.

h) Successful highest bidder shall have to deposit 1%TDS on income, 3% Education Cess and Surcharge, if applicable, as per Section 206C of the Income Tax Act along with the balance 75% of bid amount in favour of the Finance officer, JNU, through DD/Pay Order/NEFT/RTGS in the University account as per details given below:

j) The highest bidder will be allowed to take out the dismantled materials from the campus within 03 days from the date of acceptance of bid after making payment of full bid amount on issue of the gate pass by the Estate Branch.

k) If the bidder does not remove the auctioned dismantle materials from the site within 10 days after depositing the full bid amount, Deputy Registrar (Estate) may confiscate the balance materials lying at site and bidder will have to pay Rs. 2000/- per day as penalty. No material shall be allowed to take out unless the penalty is paid by the bidder.
