



**Conditions: -**

- The quotation for the work shall remain open for a period of 15 days from the date of opening of quotations. The contractor shall be debarred from the JNU for one year if he withdraw their NIQ before validity period.
- The work shall be carried out as per specifications/make defined in the NIQ.
- All taxes shall be deducted as per Govt. of India rules applicable.
- Time allowed for completion of above work is 07 days. The contractor shall be debarred from the JNU for one year, if contractor fails take up and complete the work within the stipulated period.
- Security deposit @7.5% of quoted amount shall be deducted from the bill of the contractor, which shall be refunded after 6 months from the date of completion.
- The firm has to produce self attested copies of all relevant documents such as Electrical Contractor License, PAN no., GST Registration and experience certificate along with the quotation.
- The contractor has to execute the work as per the schedule given by the JNU
- The quoted rates shall be inclusive of all taxes, cartage etc.
- Payment shall be made after satisfactory completion of work.
- The Quotation and the Earnest Money declaration form in respect lieu of EMD exemption along with requisite documents shall be placed in separate sealed envelopes, each marked, "Quotation" and "EMD declaration form and other documents" respectively. Both the envelopes shall be submitted together in another sealed envelope with the name of work and due date of opening written on envelope. The envelopes marked, "Quotation" of only those Quotationers shall be opened, whose EMD declaration form and other documents, placed in the other envelope, is found to be in order.
