



Conditions:-

4. Time allowed for completion of above work is **60 days**.

6. Security deposit @7.5% of quoted amount shall be recovered from the bills paid to the agency and the same shall be refunded after warranty period of six months.

8. The firm has to produce self attested copies of all relevant documents such as PAN no., GST electrical contractor License etc. along with the quotation.
9. The quoted rates shall be inclusive of all taxes, cartage etc and nothing shall be paid extra over / above quoted rates.
